I don't know how the Council could even be considering a new pool and library complex that would cost in excess of \$20m when the greater Milton area only has a population of around 4000 and the majority of those rarely if ever use either facility. You have not even offered estimates of the cost of repairs or replacement of the pool at the existing location, which is a much more convenient location than in the middle of town, nor have you provided costs for the upgrade of the library. Libraries are used less now than in the past as most homes have internet access and schools are taking on holiday programs, which is the best place for that as they have the resource to do so. To say the single-story Library needs to be replaced because it is an earthquake risk is a pathetic reason to want to destroy it. Simeon Brown, the minister of local government has advised Councils that during the present fiscal situation now is not the time for councils to be spending large amounts of money on nice to have projects, but should instead be concentrating on need to haves, and there are plenty of need to haves in the infrastructure of the Clutha District Council area. I am in full agreement with him. I am aware that a considerable amount of money has already been spent on the planning of a new library/swimming pool complex and that the majority of that money could be lost if the project doesn't go ahead, but I believe the Council has been negligent in going this far without keeping ratepayers informed about the cost and logistics of alternatives. The Balmoral-Tuapeka Rural Water Scheme Committee would like to submit in support of the Bruce Community, in making a decision to build, or not, the new Bruce Community and Swimming Pool facility. This project's forecasted cost blowout, is something we sympathise with fully, and would like to complement this community in their efforts in the fund raising arena, and also acknowledge the support the Clutha District Council has offered the community in working together to get this project underway. However, we notice on the Clutha District Council's website page dedicated to the Bruce Facility Project, under the Frequently Asked Questions section, there is a statement we would like to highlight and draw Council's attention to, which is the question, Who will pay and how? In the answer, it clearly states that Council has confirmed that the Central Government Three Waters Better Off Funding Support package will be used to help meet some of the project's costs. It is our clear view that a swimming pool and community facility "does not" meet the Three Waters Better Off Funding Support criteria, and to strengthen our position, in the same section, it states there is a risk with this funding support because the "Government has signalled a preference that this funding be used on Three Waters Projects". As you are fully aware, there are Three Waters projects in our District well under way that are screaming out for financial support, to help make the cost of building and delivering these Three Waters Projects, affordable for ratepayers and consumers. If there was not a Three Waters Project or projects in dire need of financial "help", directing this Better Off Funding to a project like the Bruce Community Facility would or could be seen as appropriate. It is our firm view that Council needs to revisit its confirmation of using this funding to support, in this case, the Bruce Facility Project, and use the Three Waters Better Off Funding for what it is intended, and granted to be used for, Three Waters Projects, like among others, the GreenFields Bore Project. Just a reminder to Council, The GreenFields Bore Project is critical infrastructure, that is

vital for Industry, Farming and Human needs within a 78,600 hectare area of the Clutha District, one which houses approximately 500,000 stock units, and will supply high quality drinking water to approximately 1650 people, which includes the townships of Waitahuna, Tuapeka Mouth and Lawrence.

SubSubmission on Bruce Community Facility¹. Thank you for the opportunity to submit on the Bruce Community Facility project. This submission has been compiled by the National Public Health Service (NPHS) Te Waipounamu Region, Health New Zealand - Te Whatu Ora. NPHS Te Waipounamu services the South Island including the Clutha District.² NPHS recognises its responsibilities to improve, promote and protect the health of people and communities of Aotearoa New Zealand under the Pae Ora Act 2022 and the Health Act 1956.³ Pae Ora requires the health sector, as one of its roles, to protect and promote healthy communities and health equity across different population groups by working together with multiple sectors to address the determinants of health.⁴ For purposes of defining equity, we use the Ministry of Health's definition. In Aotearoa New Zealand people have differences in health that are not only avoidable, but unfair and unjust. Equity recognises different people with different levels of advantage require different approaches and resources to get equitable health outcomes.⁵ This submission responds to some of the options provided in the Bruce Community Facility Proposal.⁶ This submission also sets out matters of interest and concern to NPHS Te Waipounamu.¹ Ministry of Health. We welcome the opportunity to comment on the consultation documents for the Bruce Community Facility project. As part of preparing this submission, we consulted with Tokomairiro Waiora to capture the voices of whānau and local communities in this proposal.⁸ Health and wellbeing are influenced by a wide range of factors beyond the health sector. These influences can be described as the conditions in which people are born, grow, live, work and age, and are impacted by environmental, social and behavioural factors. They are often

referred to as the 'social determinants of health'.²⁹The diagram³ below shows how these determinants are interlinked and complex. Initiatives to improve health outcomes and overall quality of life must involve organisations and groups beyond the health sector, such as local government if they are to have a significant impact.⁴Specific Comments¹⁰.NPHS supports Option 1 – the development of a new community library and pool facility with six swimming lanes. We believe that investing in such a facility is essential from a public health perspective for the long-term health and well-being of the Milton and wider Bruce area communities. We highlight this proposal's benefits of promoting physical activity, mental well-being, and social connection.² Public Health Advisory Committee. Health affairs. 2002 Mar;21(2):78-93.¹¹.A swimming pool in the community will improve opportunities for physical activity for people of all ages, ranging from children learning to swim, to older people. Regular physical activity is associated with many positive health outcomes, including reducing the risk of obesity, heart disease, type 2 diabetes and cancer and helping to manage depression.⁵ However, physical activity levels in New Zealand are decreasing, and unhealthy weight is among the top five risk factors for health loss and premature death.^{6,7}¹².The facility would also provide spaces for social interaction and mental well-being through the nearby library and multipurpose areas, which are quite important in rural and semi-rural communities. Evidence shows that there are increasing concerns about isolation and mental health issues in rural areas of New Zealand. Suicide rates have historically been higher in rural communities than in urban communities. This facility would act as a connecting place for families, older people, and individuals to come together, access support, and participate in community activities.⁸¹³.From a public health perspective, choosing Option One offers a long-term solution rather than simply responding to immediate needs. While the project has costs, a purpose-built modern facility that promotes health, education, and community cohesion will provide a long-term investment in the well-being of the entire community.The facility is designed to meet current and future needs as the Bruce area grows. This investment avoids the higher cost of constantly repairing older infrastructure, unlike Option Two, that presents risks like health and safety hazards, disruption of services, higher repair costs, or even the closure of the facility.The rate increase under Option 1 may financially impact households, particularly in the current economic climate. This increase could pressure low-income families, especially in rural areas like Milton, for which the council could consider strategies like rebates for low-income households.¹⁴.The facility would benefit a part of the Clutha community that has a lower socioeconomic profile. Additionally, having these community facilities within the local area reduces the need for community members to travel long distances to access health and well-being-promoting facilities, which is especially beneficial for low-income families, people with disabilities, children, and older people.¹⁵.We also recommend that if Option One proceeds, the facility incorporates universal design principles, ensuring the inclusion of accessible toilets, drinking water fountains, entrances and pathways, making it accessible to everyone. Accessibility needs may relate to mobility scooters, prams and individuals with language, visual, or intellectual disabilities. Submission on Bruce Community Facility

1. Thank you for the opportunity to submit on the Bruce Community Facility project. This submission has been compiled by the National Public Health Service (NPHS) Te Waipounamu Region, Health New Zealand - Te Whatu Ora. NPHS Te Waipounamu services the South Island including the Clutha District.
2. NPHS recognises its responsibilities to improve, promote and protect the health of people and communities of Aotearoa New Zealand under the Pae Ora Act 2022 and the Health Act 1956.
3. Pae Ora requires the health sector, as one of its roles, to protect and promote healthy communities and health equity across different population groups by working together with multiple sectors to address the determinants of health.
4. For purposes of defining equity, we use the Ministry of Health's definition.
*In Aotearoa New Zealand people have differences in health that are not only avoidable, but unfair and unjust. Equity recognises different people with different levels of advantage require different approaches and resources to get equitable health outcomes.*¹
5. This submission responds to some of the options provided in the Bruce Community Facility Proposal.
6. This submission also sets out matters of interest and concern to NPHS Te Waipounamu.

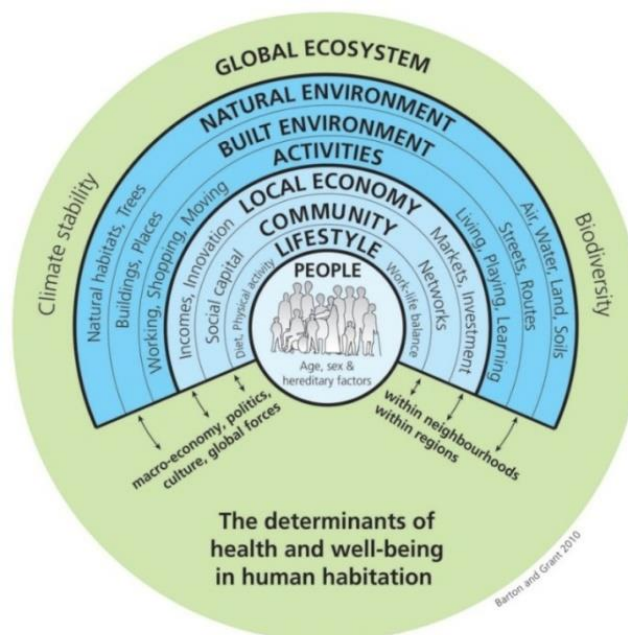

General Comments

7. We welcome the opportunity to comment on the consultation documents for the Bruce Community Facility project. As part of preparing this submission, we consulted with Tokomairiro Waiora to capture the voices of whānau and local communities in this proposal.
8. Health and wellbeing are influenced by a wide range of factors beyond the health sector. These influences can be described as the conditions in which people are born, grow, live, work and age, and are impacted by environmental, social and behavioural factors. They are often referred to as the 'social determinants of health.'²
9. The diagram³ below shows how these determinants are interlinked and complex. Initiatives to improve health outcomes and overall quality of life must involve organisations and groups beyond the health sector, such as local government if they are to have a significant impact.⁴



Specific Comments

10. NPHS supports Option 1 – the development of a new community library and pool facility with six swimming lanes. We believe that investing in such a facility is essential from a public health perspective for the long-term health and well-being of the Milton and wider Bruce area communities. We highlight this proposal's benefits of promoting physical activity, mental well-being, and social connection.

11. A swimming pool in the community will improve opportunities for physical activity for people of all ages, ranging from children learning to swim, to older people. Regular physical activity is associated with many positive health outcomes, including reducing the risk of obesity, heart disease, type 2 diabetes and cancer and helping to manage depression.⁵ However, physical activity levels in New Zealand are decreasing, and unhealthy weight is among the top five risk factors for health loss and premature death.^{6,7}
12. The facility would also provide spaces for social interaction and mental well-being through the nearby library and multipurpose areas, which are quite important in rural and semi-rural communities. Evidence shows that there are increasing concerns about isolation and mental health issues in rural areas of New Zealand. Suicide rates have historically been higher in rural communities than in urban communities. This facility would act as a connecting place for families, older people, and individuals to come together, access support, and participate in community activities.⁸
13. From a public health perspective, choosing Option One offers a long-term solution rather than simply responding to immediate needs. While the project has costs, a purpose-built modern facility that promotes health, education, and community cohesion will provide a long-term investment in the well-being of the entire community.

The facility is designed to meet current and future needs as the Bruce area grows. This investment avoids the higher cost of constantly repairing older infrastructure, unlike Option Two, that presents risks like health and safety hazards, disruption of services, higher repair costs, or even the closure of the facility.

The rate increase under Option 1 may financially impact households, particularly in the current economic climate. This increase could pressure low-income families, especially in rural areas like Milton, for which the council could consider strategies like rebates for low-income households.

14. The facility would benefit a part of the Clutha community that has a lower socioeconomic profile. Additionally, having these community facilities within the local area reduces the need for community members to travel long distances to access health and well-being-promoting facilities, which is especially beneficial for low-income families, people with disabilities, children, and older people.
15. We also recommend that if Option One proceeds, the facility incorporates universal design principles, ensuring the inclusion of accessible toilets, drinking water fountains, entrances and pathways, making it accessible to everyone. Accessibility needs may relate to mobility scooters, prams and individuals with language, visual, or intellectual disabilities. We note that accessible parking has already been included in the facility specifications, designs and

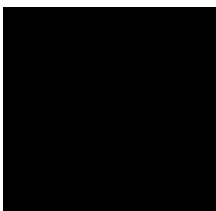

As an Advanced Scope Orthopaedic Physiotherapist leading the Southern Community orthopaedic triage service (SCOTS), I understand the challenges facing a growing number of our community who struggle with persistent musculoskeletal pain. Health NZ has placed an emphasis, and funding, on supporting this group of people to remain independent and active members of society. Our non-surgical options, therefore, are growing, with evidence internationally supporting exercise as the first line of management for persistent musculoskeletal pain. Osteoarthritis is a weight-bearing condition. Treatment options that involve strengthening in a reduced weight-bearing context (such as pool therapy), therefore, are likely to be more successful than other management options. Currently the pool with the best access for less able users is the Mosgiel pool. It has become very popular amongst my patient population from all around the region because of ease of access. The care and consideration that has gone into the new Milton pool facility in terms of ramp access and easy parking should ensure that the entire Clutha District will benefit from the Milton pool, without any reliance on the Mosgiel pool, some 44km distant from Milton. The Balclutha pool, while an admirable facility for what it provides, does not have ramp access to its large pool, thereby excluding some participants from therapy. Patients report that they use the Mosgiel pool along with others who share the same journey. They then emerge from the pool and carry on their day together in a cafe, thereby contributing to the local economy. Many of my patients are from the Clutha District: to have a facility that supports their osteoarthritis journey and keeps them active and independent contributors to the community is so important to their own sense of wellbeing and to the wellbeing of community. I strongly endorse the construction of a new community aquatic facility in Milton. The benefits to the health of the Clutha District community far outweigh any detriment caused by rates increases. Rehabilitate here, engage socially here, spend your money here: support the new aquatic facility for

the good of our community.

As a long-term ratepayer of some 48 years in the Bruce Community Facilities Rating Area, I offer my full support for the implementation of Option 1 in Milton Township. It is very evident, supported by research into costings and future suitability, that the existing Milton Library, and the Centennial Pool facility, have reached the end of their respective functional lifespans, and both are in urgent need of replacement if they are to remain as viable facilities in the town. I believe that both of these facilities should be considered as "essential" for present and future residents of not only Milton township, but also of the productive rural areas surrounding it. Efforts which have recently been made to attract and retain industry and institutions in the Bruce Ward have created employment opportunities and growth potential which have been taken up by non-residents and Milton residents alike. I believe that it would be greatly advantageous to encourage more families to move to the district, but the decision to take that action is often complicated by the availability and attractiveness of community facilities, compared to what the family may be leaving. While the provision of a modern community library and swimming pool will not necessarily answer all of those requirements for prospective new residents, such facilities are an attraction, and perhaps an indication of the desire by present residents, and the administrative body such as CDC, to be seen as progressive in their thinking and actions. Such "thinking" has limitations of course, primarily financial, and while fiscal responsibility on behalf of Council is expected by ratepayers at all times, that should always be tempered by a vision for the future, whereby expenditure made now can be justified by a long-term vision for the benefit of future residents, particularly those families with children. I personally believe it would be fiscally irresponsible for Council to expend further funds on trying to upgrade or retain the existing library and pool facilities in their separate localities as at present. We cannot ignore the fact that our overall population is an ageing one, and Milton district is no exception to that phenomenon

either. Those of us in the retirement category naturally give consideration to the future for our grandchildren and perhaps our great-grandchildren, and it is pleasing to see that the proposed facility includes provisions for both ends of the age spectrum. I would imagine that the use of the "community spaces" in the proposed complex might provide hosting opportunities for both public events, and private engagements such as children's birthday parties where the pool would be a major attraction for entertainment. With respect to funding of the new complex, I note a 25 year loan repayment period is proposed, which is reflected in the estimates of rates increases for the district. I would question the term selected, given that 25 years is less than a generation, and not even as long as the average home loan currently. A term of perhaps 30 or 35 years might lessen the rates impact, although paying off any loan in a shorter period is always desirable for any borrower, and Council is no exception to that rule. However, the 25 year term repayment, plus estimated annual running costs for the facility, amounts to about \$1 per day additional costs for ratepayers over that time, a fact that perhaps should be emphasised a little more in promotion of the project within the community. In re-affirming my support for Option 1), to proceed with the proposed Library and swimming pool development in Milton, I would submit that the success of a community is measured not only by what is done in the here and now for current members, but is also reflected by the legacy left behind by us for future generations to enjoy and benefit from. Anything done to improve and future-proof key infrastructural services, plus the provision of community well-being facilities, will enhance the attractiveness of the town, and speak highly of the vision and foresight of current decision-makers, as well as help to install a sense of pride within the community. So what happens then? We start the long, drawn-out process all over again? Get new quotes which will, without fail, only have increased in cost? Essentially, throw good money after bad. But Council is already well aware of those issues. Fundamentally, this consultation should not be about a binary question of YES, we want a new, modern facility, worthy of our district and our community, or NO, we want to continue with the old, and see if we can make a plan to drag out the (already been and gone) expiry dates of the existing buildings. We all know we want a new facility, we’ve been saying it over and over and over again for the past 5 years. Even the detractors agree. But there’s that eternal question: where do we find the money? So, what this consultation should be about is engaging with the community, with the entire district, about the HOW. HOW do we green-light a facility that both supporters and detractors agree “everyone wants”, but the concerns are purely financial? 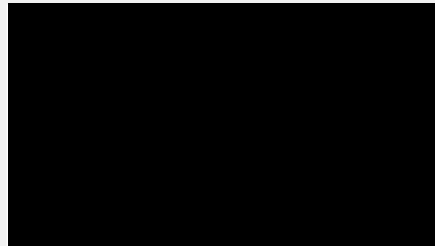

It was fairly obvious in the town meetings, that it is unanimously accepted that we need new facilities (in particular the pool), however the execution of this task is under scrutiny. The inevitable trotting out of: how the location is wrong, why are there not multiple options with corresponding quotes, why can't we just have either a new pool OR a new library, lets limp the old pool along until the economy improves, the Library just needs a lick of paint... were simply travelling over old ground. My take-away from the meetings was that (unsurprisingly) the rates increase is the only real issue standing in the way of the continuation of the project. I believe the people with these concerns can be broken down into two groups: 1) Community members with a generalised opposition to the cost of the facility. The reality of this groups actual inability to furnish the \$264 - \$310 cost per annum is unclear, despite the indignant and outraged statements about unaffordability. My observation is that this group consists of mainly older people with perhaps an unwillingness to contribute, rather than an inability. 2) Community members who will genuinely be put under excessive financial strain by the additional rates cost. I believe that the facility will not only provide myriad benefits in terms of services, recreational and therapeutic opportunities, physical, social and educational wellbeing, but will also create a ripple of growth and positive change. Milton is dated, unattractive and unappealing to visitors and potential residents. Our community is accustomed to the 'bare minimum' and in many cases embraces that. But we have a generation of adults and our children who want the future to be different. We cannot risk the future prospects of our town, ward and district because we "can't afford" to have vision today. So, the question is not if the facility should be built - that is an absolute no-brainer. The question is, how do we acknowledge our poverty and wrap around our most vulnerable homeowners and rent-payers to alleviate the added financial pressure. There is more than one way to skin a cat. Community and Council need to shift gears, think laterally about

how to make this happen and get moving or the future will leave us behind to stagnate for another 40 years.

There are still many questions that need to be answered regarding the pool project. Suddenly, the Bruce Community no longer needs to fundraise the \$2 million required for the project to proceed. This raises the assumption that the ratepayer will be picking up the tab once again. Additionally, Councillor Catherwood raised questions about the calculations used to estimate the impact on rates. Any extra costs or overruns will be onerous for the ratepayers, especially those in the Bruce area. For example, the \$1 million extra cost to build the foundations to future-proof the pool for earthquakes was conveniently left out. There are also ongoing questions about the "Better Off" funding. The government is unhappy that this funding is being allocated to the pool instead of infrastructure, as they have already requested that the council reallocate it to our core water services. As I mentioned, the Bruce community was supposed to fundraise \$2 million towards the cost of the pool but has fallen short, even with the extraordinary effort they have put in during this current economic climate. Any shortfall will need to be funded by the ratepayer. I would hate to think that the money donated so far could have meant other charities and community groups missed out on funding. Although the pool was initially promoted as a facility for children, it appears more suited for Boomers to relax in a spa and those fortunate enough not to work long hours to cover recent rate rises can enjoy a few laps before their next Frappuccino latte. While there is a paddling pool for parents with young toddlers, there is a noticeable lack of fun amenities for older kids—no water slides, no diving pool, no wave pool. This lack of features tends to overlook the needs of children older than toddlers but younger than adults missing a huge demographic contradicting the original promise. Additionally, the council often gets these grand plans approved, but the ratepayer ends up with the old bait and switch. Look at what was promised for the Stewart Reserve and what was delivered. Similarly, the Clutha destination toilets and the Milton streetscape projects did not meet

the initial promises. These examples highlight a pattern of over-promising and under-delivering, which raises concerns about the pool project's potential outcomes.

Bruce Community Facilities Trust Committee Bruce Community Facility CDC Consultation October 2024 We the Bruce Community Facilities Trust Committee support option 1 We wish to speak in support of our submission. Vision: To develop a vibrant, contemporary multi-purpose community facility which fosters an appreciation for a healthy, balanced and enriched lifestyle. The Clutha District Council and the Bruce Community Facilities Trust, backed by the wider community have been working towards creating a new facility that will provide a wide range of benefits to Milton, the Bruce District and the wider Clutha District. The Bruce Community Facility will improve accessibility, livability, and community wellbeing, and help to facilitate economic growth. At its core, this project is about bringing people together, through the provision of shared facilities and essential community-based services. This will be a facility that caters for people of all ages and backgrounds, and with diverse interests. The facility, a combined Library, Service Centre and Aquatic Centre aims to replace the current disjointed and outdated infrastructure and transform the centre of Milton into a destination location that is well used and enjoyed by members of the community and visitors alike. Some facts: Population of the Bruce District is approx. 4,000 and growing. School roles across the four schools in Milton and Waiholo and Taieri Mouth total 450 primary and secondary students. The nearest pools are in Balclutha, 27km and Mosgiel 44km away. This means a combination of cost and time rules out swimming in school time if Milton pool closes permanently. Council data shows total attendance levels in 2022/23 for the Milton pool were 5,500, 45% were school visits. This is down from a peak of 19,000 in 2010/11. We believe the poor state of the pool and the low temperature have contributed to this drop off in volumes. Swim NZ states 3 swims per population is low, 6 is ideal, 9 is high. With 5,500 swims Milton is low at 2.5 swims per pop, across the Bruce District 1.3 swims per population is very low. During 2023 NZ lost 90 people from

drowning, 1.7 per 100,000, third worst in developed world. Australia has 1.1 per 100,000. Our current library is far too small and being originally built and designed as an office is not fit for purpose.

Benefits: The key benefits gained by a combined facility include helping to create a sense of community, creating a focal point, and helping to transition Milton from a small rural town to more of a 'destination' experience. With the bike trail completed, the main street upgrade and a subdivision underway the opportunity and time to both provide and significantly improve the recreational experiences for residents, visitors and passing tourists is now. A new pool open year-round as against the current 6 months from mid-October to Easter would be a significant benefit for our community. Modern libraries are wonderful active learning spaces with multiple resources for the whole community. Our service centre provides an essential service across a wide range of community needs. Wider District benefit: A new Milton pool would be the only pool in the Clutha District open year-round with a ramp. This would mean people may choose to travel from further afield than the Bruce District to swim or do hydrotherapy, in particular during the easter to labour weekend normal close down period for other pools. It would also make sense for Balclutha and Milton's new pool to stagger maintenance shut down times so there was always one of the pools open.

Bruce Community Facilities Trust Update: Council is aware of the fundraising from previous updates. We have so far raised \$200,000. We have been maintaining relationships with funding agencies as we work towards our \$2m target.

Conclusion: Community has been consulted twice, during consultation young people fed back that they would value having a swimming pool that is operational year-round and available throughout a longer swim season. It has also been agreed that a combined library/service centre/ pool is the most efficient way to provide these facilities. We the Bruce Community Facilities Trust Committee support option 1

We wish to speak in support of our submission.

Vision:

To develop a vibrant, contemporary multi-purpose community facility which fosters an appreciation for a healthy, balanced and enriched lifestyle.

The Clutha District Council and the Bruce Community Facilities Trust, backed by the wider community have been working towards creating a new facility that will provide a wide range of benefits to Milton, the Bruce District and the wider Clutha District. The Bruce Community Facility will improve accessibility, livability, and community wellbeing, and help to facilitate economic growth. At its core, this project is about bringing people together, through the provision of shared facilities and essential community-based services.

This will be a facility that caters for people of all ages and backgrounds, and with diverse interests.

The facility, a combined Library, Service Centre and Aquatic Centre aims to replace the current disjointed and outdated infrastructure and transform the centre of Milton into a destination location that is well used and enjoyed by members of the community and visitors alike

Some facts:

Population of the Bruce District is approx. 4,000 and growing.

School roles across the four schools in Milton and Waihola and Taieri Mouth total 450 primary and secondary students.

The nearest pools are in Balclutha, 27km and Mosgiel 44km away. This means a combination of cost and time rules out swimming in school time if Milton pool closes permanently.

Council data shows total attendance levels in 2022/23 for the Milton pool were 5,500, 45% were school visits. This is down from a peak of 19,000 in 2010/11. We believe the poor state of the pool and the low temperature have contributed to this drop off in volumes.

Swim NZ states **3 swims per population** is low, 6 is ideal, 9 is high. With 5,500 swims Milton is low at 2.5 swims per pop, across the Bruce District 1.3 swims per population is very low. During 2023 NZ lost 90 people from drowning, 1.7 per 100,000, third worst in developed world. Australia has 1.1 per 100,000. Our current library is far too small and being originally built and designed as an office is not fit for purpose.

Benefits: The key benefits gained by a combined facility include helping to create a sense of community, creating a focal point, and helping to transition Milton from a small rural town to more of a 'destination' experience. With the bike trail completed, the main street upgrade and a subdivision underway the opportunity and time to both provide and significantly improve the recreational experiences for residents, visitors and passing tourists is now.

A new pool open year-round as against the current 6 months from mid-October to Easter would be a significant benefit for our community. Modern libraries are wonderful active learning spaces with multiple resources for the whole community. Our service centre provides an essential service across a wide range of community needs.

Wider District benefit: A new Milton pool would be the only pool in the Clutha District open year-round with a ramp. This would mean people may choose to travel from further afield than the Bruce District to swim or do hydrotherapy, in particular during the easter to labour weekend normal close down period for other pools. It would also make sense for Balclutha and Milton's new pool to stagger maintenance shut down times so there was always one of the pools open.

Bruce Community Facilities Trust Update:

Council is aware of the fundraising from previous updates. We have so far raised \$200,000. We have been maintaining relationships with funding agencies as we work towards our \$2m target.

Conclusion:

Community has been consulted twice, during consultation young people fed back that they would value having a swimming pool that is operational year-round and available throughout a longer swim season. It has also been agreed that a combined library/service centre/ pool is the most efficient way to provide these facilities.
